Universiti Malaya's Commitment to Peace, Justice and Strong Institutions

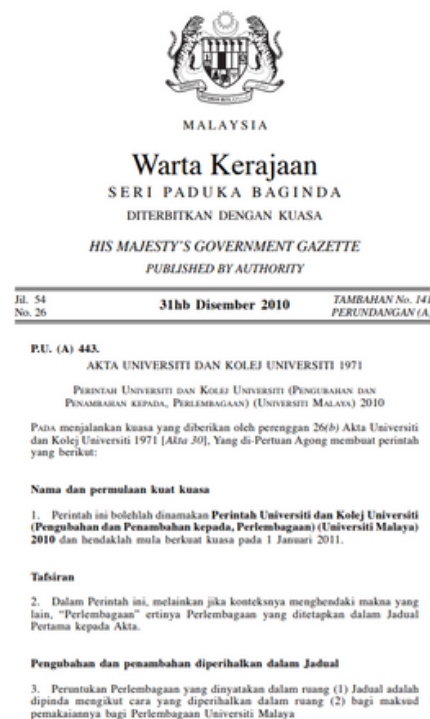
Universiti Malaya (UM) continues to uphold its leadership role in advancing Sustainable Development Goal 16 (SDG 16), which is centred on promoting peace, justice, and strong institutions. In 2023, the university's efforts in this area have been intricately woven into its broader strategic vision, as outlined in the UM Transformation Plan 2030 and the UM Master Plan 2050. These frameworks serve as guiding pillars, ensuring that UM's initiatives not only contribute to local and national development but also align with global sustainability trends and priorities.

This report provides an in-depth overview of UM's 2023 initiatives in governance, anti-corruption, academic freedom, community engagement, and legal education, showcasing how these efforts align with and reinforce global SDG 16 objectives. Through these initiatives, UM remains committed to fostering resilient institutions and equitable justice, reinforcing its role as a leader in sustainable development.

Governance and Institutional Integrity

Universiti Malaya (UM) has taken significant steps to reinforce its governance structures, ensuring that they are both transparent and inclusive. The university's governance model emphasises participation from a broad spectrum of stakeholders, including faculty members, non-faculty staff, students, and external community representatives. This inclusive governance framework ensures that decisions reflect the diverse interests of all university stakeholders, thereby fostering a culture of openness and accountability. UM adheres to national laws governing university administration, as outlined in the Universities and University Colleges Act 1971 and has been further strengthened with the implementation of the University of Malaya Constitution 2010. The UM Management structure is designed to facilitate broad participation in decision-making processes. Faculty members, administrative staff, and student representatives are integral parts of the Senate Council and various committees, allowing them to contribute to policies and strategies that affect the entire university community. For example, student representatives play a key role in discussions related to academic policies, campus life, and student welfare, ensuring that the voices of the student body are heard and considered in the university's strategic planning.

UM's governance extends beyond the campus to include external stakeholders such as local community leaders, government officials, and industry partners. For example, the Board of Directors for Universiti Malaya includes Ministry of Higher Education Representative, Ministry of Finance Representative, Community Representative, Private Sector Representative, Alumni Representative and Knowledgeable & Experienced Representative.

The inclusion of these external stakeholders in governance processes not only strengthens UM's institutional integrity but also ensures that the university's policies and initiatives are aligned with broader societal needs. This approach has positioned UM as a model for governance in higher education, demonstrating how universities can act as engines of social and economic development while maintaining strong institutional integrity.

Furthermore, the Universiti Management Committee (JKPU) includes not only faculty members but also key representatives from various non-academic departments to ensure a comprehensive approach to university governance. Among these are representatives from Corporate Strategy, who provide strategic direction and planning insights; the Bursar's office, which oversees financial management and budgeting; UM Medical Centre (UMMC), which contributes healthcare expertise and operational insights; the Corporate Communications Centre (CCC), responsible for managing the university's public relations and communications; and the Legal Division, which ensures compliance with legal requirements and offers guidance on regulatory matters. This diverse composition enables JKPU to address a broad range of university matters with input from different perspectives across the institution.

Promoting Integrity and Sustainable Governance: UM's Commitment to SDG 16 and Ethical Education

The Universiti Malaya's "Integrity Sustainability Course in Organisations: Where Are We?" held on 13 April 2023, aligns with the institution's commitment to the United Nations Sustainable Development Goals (SDGs), particularly SDG 16: Peace, Justice, and Strong Institutions, and SDG 4: Quality Education. This course, organised by UM's Human Talent Development Division and the Integrity Unit, aimed to bolster organisational integrity and promote ethical governance by equipping participants with knowledge on integrity principles, abuse of power, and anti-corruption practices.

By addressing real case studies and regulatory frameworks, the program sought to build transparent, accountable, and resilient institutions that uphold justice and moral values - key targets of SDG 16. Additionally, by fostering an environment where continuous education in integrity is prioritised, UM contributes to SDG 4, ensuring inclusive and equitable quality education that promotes lifelong learning and responsible citizenship. Through these efforts, Universiti Malaya demonstrates its dedication to embedding sustainable, ethical practices at all institutional levels, creating a ripple effect that strengthens societal integrity and justice in alignment with the SDGs.

Universiti Malaya's Recognition of Independent Students' Union

Universiti Malaya (UM) officially recognises the independent Universiti Malaya Students' Union (UMSU) as an integral part of the university community. UMSU plays a vital role in university governance, championing student welfare, and enhancing the vibrancy of campus life.

- **Governance Input:** UMSU plays an active role in university governance, with representation in over 20 governing committees, as detailed in the 2022 UM Annual Report (pages 46-48). Student representatives participate in university management committees and senate meetings, where they advocate for student interests. This involvement ensures that student perspectives are considered in important decisions affecting the university community.
- **Social Activities:** UMSU organises and supports a range of social activities, promoting campus engagement and community building. These activities include volunteer-led sustainability initiatives and events run by student groups, as highlighted in the portfolio of social activities (Sustainability and Student Activities).

- **Student Support:** UMSU provides a range of support services focused on enhancing student welfare, including guidance, resources, and advocacy. Serving as a liaison between students and university administration, UMSU ensures that student needs and concerns are addressed promptly and effectively. As the governing student body, UMSU is also responsible for approving club and society activities. Additionally, campus elections are managed by the student body, with advisory and support from the Student Affairs Department (HEP).

Through these functions, the UM Students' Union is instrumental in empowering students and fostering a dynamic, inclusive university community.

The UM Board of Directors is composed of esteemed representatives from key sectors, including industry experts, Ministry representatives, community leaders, and alumni ([Part III, The University Authorities, Constitution of the University of Malaya](#)). This diverse and carefully selected Board ensures that UM's leadership reflects a broad array of perspectives, advancing UM's mission to serve both the nation and humanity through academic excellence, inclusive governance, and collaborative partnerships. The involvement of local community stakeholders - such as local residents, civil society organisations, and local government representatives - is actively encouraged, aligning with UM's commitment to inclusive governance. This policy guarantees that all voices, including those from marginalised communities, are heard and represented through structured feedback mechanisms that promote meaningful participation in university decision-making.

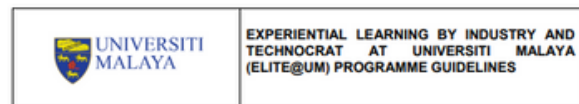

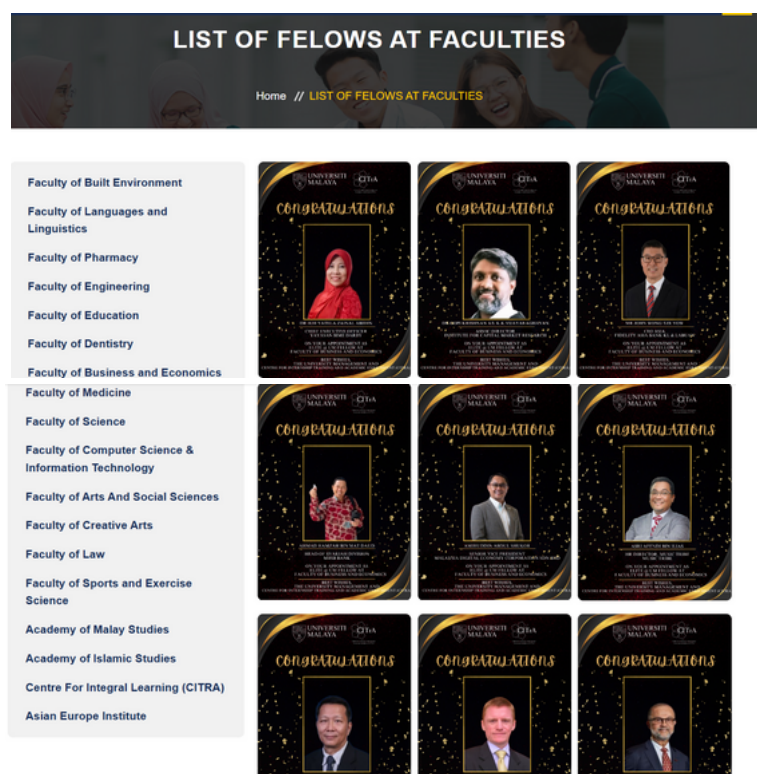

The Dialogue on Inclusivity and Peace, hosted in collaboration with the Regional Network for Peacebuilders and several interfaith organisations, exemplifies UM's active role in fulfilling SDG 16. This event fostered discussions on religious tolerance, gender equality, and social inclusion, laying groundwork for increased mutual understanding across the region. By supporting initiatives like these, UM enhances civil society's role in peacebuilding, empowering stakeholders across South and Southeast Asia to address complex social challenges. Furthermore, UMCCD's work aligns with SDG 16 by equipping participants with skills and frameworks for ongoing peace and inclusivity efforts. Such events emphasise the university's long-term dedication to positive societal transformation, positioning UM as a leader in interfaith and intercultural dialogue in the academic world.

Additionally, UM's commitment to social responsibility extends to its educational programs. The university offers a range of courses and workshops designed to educate students and community members about the importance of civic engagement, ethical leadership, and social justice. These programs help to build a culture of active citizenship and social responsibility, empowering individuals to contribute to the development of just and equitable societies.

The Bulletin UMCCD (Vol. 43, July-Sept 2023) provides updates on various impactful programs led by the UM Centre for Civilisational Dialogue (UMCCD), including dialogues and workshops focused on fostering peace, inclusivity, and sustainability. Notable events featured include the AUA UI-UM Deep Dive Program on Asian Civilisations, International Youth Day 2023, and symposia on harmony and sustainability leadership. Moreover, UM faculty members are directly involved in providing expert advice to national organisations through their roles on various committees. In 2023, Universiti Malaya faculty members contribute to both national and international efforts, with **26 international and 117 national involvements** (refer to the tables below). This expert engagement contributes significantly to policy development and industry standards across a wide range of sectors: For instance, Associate Prof. Sr Dr. Mohd Suhaimi Mohd Danuri, from the Faculty of Built Environment, serves on the Board of Quantity Surveyors Malaysia (LJBM) (2023-2025). His role includes implementing strategic plans, preparing annual budgets, and supporting the Assessment of Professional Competence (APC). His efforts contribute to raising industry standards and strengthening the quantity surveying profession in Malaysia.

In addition, UM has undertaken significant research in collaboration with government departments, with over 114 active projects involving government agencies in 2023 alone. Among these, seven projects are dedicated specifically to policy-focused research, addressing critical societal issues and contributing to national policy formulation. Each of these projects is supported by prominent funding bodies, reinforcing UM's commitment to targeted, impactful research. **The funded policy-focused projects** include:

1. **Development of a Psychospiritual Therapy Workbook** for elderly well-being and caregiver training, funded by the **Lembaga Penduduk dan Pembangunan Keluarga Negara (LPPKN)**.
2. **Neurorehabilitation Program Guidelines** for adults with severe brain injuries in Malaysia, supported by the **Yayasan Penyelidikan Otak, Minda dan Neurosains Malaysia**.
3. **Leadership Model Development** for Malaysia's Teacher Education Institutes, funded by the **Jabatan Perdana Menteri (JPM)**.

4. **High-Performance Leadership Model for Religious Secondary Schools** in Malaysia, sponsored by the **Majlis Agama Islam Selangor (MAIS)**.
5. **Guideline for Managing Abandoned and Repurposed Buildings** due to obsolescence, supported by the **Institut Penilaian Negara (INSPEN)**.
6. **Open-Badges Learning (OBL) Guideline** to provide future-oriented credentials, funded by the **Agensi Kelayakan Malaysia (MQA)**.
7. **Complaints Handling Guidelines for Property Managers** focusing on service quality dimensions, sponsored by **Institut Penilaian Negara (INSPEN)**.

These initiatives highlight UM's role in advancing **policy-oriented research** that not only influences policy-making but also addresses pressing industry challenges. Through these collaborations with government agencies and key funders, UM reaffirms its commitment to **practical, research-driven solutions** that support SDG 16's vision of building effective, accountable institutions, while contributing to societal advancement and well-being.

Through these diverse efforts, UM not only strengthens its engagement with the community but also plays a vital role in shaping national policies and standards, furthering its mission of fostering peace, justice, and strong institutions, as outlined by SDG 16.

These initiatives reflect UM's dedication to fostering a corruption-free, respectful, and ethical environment that aligns with global anti-corruption and integrity standards, equipping its staff with the knowledge and values essential to upholding the university's reputation as a model of ethical governance.

Universiti Malaya (UM) has implemented a series of initiatives to enhance awareness and foster integrity, with a focus on combating corruption, bribery, and unethical practices. These efforts include specialised training programs like Program Transformasi Minda, and workshops on organisational integrity and professional etiquette, involving hundreds of staff. 
Academic Freedom and Institutional Autonomy

Legal Education and Advocacy

Universiti Malaya has a long-standing tradition of excellence in legal education, which plays a critical role in advancing SDG 16. The Faculty of Law at UM is renowned for its rigorous academic programs and its commitment to producing graduates who are well-equipped to uphold the principles of justice, human rights, and the rule of law.

In 2023, the Faculty of Law continued to be a leader in legal education, offering a comprehensive curriculum that covers a wide range of legal disciplines, including constitutional law, human rights law, and international law. The faculty also emphasises the importance of practical experience, providing students with opportunities to participate in moot court competitions, internships, and legal clinics. These experiences are invaluable in preparing students for careers in the legal profession, where they can make meaningful contributions to the promotion of justice and the protection of human rights.

UM's Faculty of Law is also actively involved in policy-focused research and advocacy. Faculty members regularly collaborate with government departments, international organisations, and civil society groups to conduct research on critical legal issues and to develop recommendations for policy reform. This research often informs the development of laws and policies at the national level, contributing to the strengthening of legal institutions and the promotion of justice in Malaysia and beyond.

Besides the Faculty of Law, the Department of Shariah and Law at the Universiti Malaya strengthens legal education by bridging Islamic and contemporary legal studies. For example, the department's focus on Islamic Finance equips graduates for roles in Malaysia's expanding Shariah-compliant financial sector, reflecting both local and global demand. Additionally, the curriculum in Islamic Family Law prepares students for positions in Shariah courts, supporting equitable family justice. Together, these programs enrich the university's contribution to SDG 16 by promoting justice across diverse legal systems.

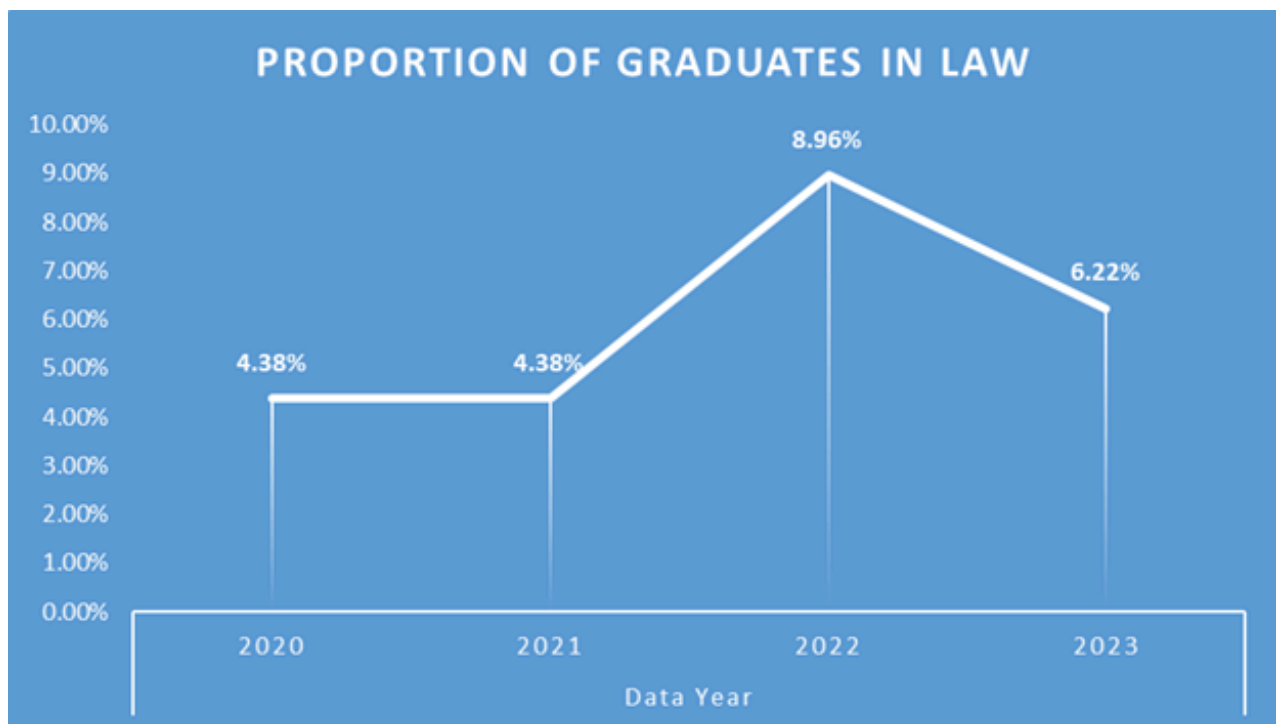
